I, the affiant, have good reason and do believe that on or about the <u>16</u> day of <u>February</u>, 20 <u>16</u>, one (name of suspect) <u>Valentine</u>, <u>Bennie Charles</u> did then and there in the City of Dallas, <u>Dallas</u> County, Texas commit the offense of <u>Murder</u>, a violation of Section <u>19.02</u> of the <u>Texas Penal Code</u>, a <u>Felony - 1st Degree</u>.

| Affiant's belief is based upon the following facts and information which Affiant received from: Affiant's personal investigation of this alleged offense. |

| , a fellow peace officer of the City of Dallas, Dallas County, Texas, who personally participated in the investigation of this alleged offense, providing this information to Affiant, and whose information Affiant believes to be credible. |
| On February 16, 2016, at approximately 5:57 p.m. Dallas Police officers responded to a cutting call at 2600 Hickory Street, Dallas, Dallas County, Texas. Officers found the complainant (John Doe) lying on the ground and deceased from what appeared to be injuries consistent with being cut/stabbed. |
| Dallas Police Officer Lipsey, 10512, who was at the offense location conducting the preliminary investigation, asked Suspect Valentine "what happened". Suspect Valentine replied, "I cut him". Suspect Valentine was transported to Dallas Police Headquarters. Detective Montenegro, # 6991, read Suspect Valentine his Miranda Warning. Suspect Valentine waived his rights to remain silent and voluntarily agreed to talk to detectives. Suspect Valentine stated that his girlfriend, "Witness Halley was jumping on her. Suspect Valentine confronted Witness Halley about her jumping on Suspect Valentine claims that Witness Halley approached him and that they both grabbed each other. At that point, Suspect Valentine claims that he felt someone hitting him with a stick across his shoulder. Suspect Valentine stated that he grabbed his knife, and struck the unidentified complainant with his knife about 2 or 3 times. Suspect Valentine stated that Witness Halley (known to him as "Peaches") then jumped on his back. He swung around and hit her with his knife cutting her. The complainant and Witness Halley ran off and Suspect Valentine stated that he looked down and saw that the stick was actually a broom. Suspect Valentine stated that he and decided that they would tell officers what happened when they arrived. While still at their tent, Suspect Valentine stated that an unknown individual walked over and took the knife and told him that he would protect him. |
| Detective Montenegro asked Suspect Valentine if he could check his shoulder for possible injuries. Suspect Valentine stated that he was not injured and that he knew he didn't have any marks because it was a broom. Crime Scene Response Section Detective Holiday, #5148, collected Suspect Valentine's clothing at Dallas Police Headquarters and checked for visible injuries. No visible injuries were observed. |
| At this time Witness Halley has not been interviewed because she is receiving medical attention at the hospital. |
| Detective Shelton, #7760, interviewed the complainant. Who was at the offense location when the disturbances occurred. She stated that she observed Suspect Valentine stab the complainant. It knows the suspect by name and sight and has lived in the same homeless camp for some time. Detective Shelton showed a single picture to the property of the positively identified the picture as Valentine who stabbed the complainant. |

The complainant has not been positively identified and will be named John Doe.
