BEFORE ME, the undersigned authority, on this day personally appeared the undersigned affiant who, after being duly sworn by me, on oath stated: My name is Scott Savers 7157 and I am a peace officer of the City of Dallas, Dallas County, Texas. I, the affiant, have good reason and do believe that on or about the 30th day of October, 2016, one (name of suspect) Lonzell Hunter did then and there in the City of Dallas, Dallas County, Texas commit the offense of Capital Murder, a violation of Section 19.03 of the Texas Penal Code, a Capital Felony.

Affiant's belief is based upon the following facts and information which Affiant received from:

- Affiant's personal investigation of this alleged offense.
 _____, a fellow peace officer of the City of Dallas, Dallas County, Texas, who personally participated in the investigation of this alleged offense, providing this information to Affiant, and whose information Affiant believes to be credible.

On October 30, 2016, at approximately 6:00 pm the complainant Martha Teran L/F [REDACTED] went to 2021 Stemmons Service Road in Dallas, Dallas County, Texas to meet with the suspect Lonzell Hunter for the purpose of selling a phone that he had agreed to buy on line. The suspect arrived and took the phone from the complainant and then shot her one time killing her. The suspect drove away from the location in a White Infinity 4dr car that a witness to this offense saw and reported to police, giving the first two digits in the tag as GX. Witness [REDACTED] who [REDACTED] of the complainant and who was standing in close proximity of the offense described the shooter with great detail and also provided a [REDACTED] and [REDACTED] for the online site that they connected with to sell the phone. Detectives reserched the information that [REDACTED] provided and linked it to the account of Lonzell Hunter. This phone number was linked to suspect Hunter's [REDACTED] as well. The likeness of suspect Hunter on his [REDACTED] was very similar to the descriptions given by [REDACTED]. Detectives also were able to locate the vehicle used in this offense and [REDACTED] and he provided a statement that he [REDACTED] suspect Hunter on the day of the offense at approximately 4:30 pm, just hours before the murder.
