ON 02/17/20201 AT APPROXIMATELY 2:00 PM ARRESTING OFFICERS(AOS) RESPONDED TO A COMPLAINT OF SMOKE COMING FROM A PUBLIC RESTROOM AT KAY BAILEY HUTCHINSON CONVENTION CENTER LOCATED AT 650 S GRIFFIN ST DALLAS, DALLAS COUNTY, TX.

UPON ENTERING THE FEMALE RESTROOM AOS HEARD A FLUSH, SMELLED FRESH CIGGARETTE SMOKE AND OBSERVED ARRESTED PERSON (AP) EXITING A STALL. AOS STOPPED AP AND NOTICED AP WAS THE ONLY PERSON IN THE RESTROOM.

AO CHECKED THE STALL AP JUST EXITED AND OBSERVED WHAT APPEARED TO BE LOOSE TOBACCO IN THE TOILET. AS AOS WERE ESCORTING AP OUT OF THE CONVENTION CENTER TO BE IDENTIFIED AND CITED FOR CITY ORDINANCE VIOLATION 41-2 SMOKING PROHIBITED, AP BECAME AGITATED AND BEGAN YELLING AT AOS.

AO ATTEMPTED TO USHER AP TOWARD THE DOORS AND AP TURNED TOWARDS AO WITH CLOSED FISTS. AO COMMANDED AP TO TURN AROUND AND CONTINUE TOWARDS THE DOORS BECAUSE HE WAS CAUSING A DISTURBANCE.

AS AO AGAIN USHERED AP TOWARDS THE DOORS HE TENSED UP AND BEGAN TO RAISE HIS HAND WHICH WAS STILL IN A FIST. AO UTILIZED AN OPEN HAND TAKE DOWN AND COMMANDED AP TO TURN OVER AND PLACE HIS HANDS BEHIND HIS BACK. AFTER SEVERAL REPEATED COMMANDS AP REFUSED TO COMPLY. AFTER A BRIEF STRUGGLE AP WAS PLACED IN HAND RESTRAINTS AND ESCORTED OUT OF THE CONVENTON CENTER.

AP WAS ARRESTED AND TRANSPORTED TO LEW STERRETT BY AOS. AP WAS IDENTIFIED BY TDCJ ID WHICH WAS ON HIS PERSON. APS PROPERTY WAS TAKEN TO BAYLOR ST PROPERTY ROOM AND LOGGED IN.
