I, the affiant, have good reason and do believe that on or about **May 21, 2017** one **BRANDON DEMON JORDAN** did then and there in the City of Dallas, Dallas County, Texas commit the offense of **Capital Murder**, a violation of section **19.03** of the Texas Penal Code, a **F/C**.

Affiant's belief is based upon the following facts and information:

J. Loeb #7751, a fellow peace officer of the City of Dallas, Dallas County, Texas, who personally participated in the investigation of this alleged offense, providing this information to affiant, and whose information affiant believes to be credible.

On **May 21, 2017**, at approximately **7:50am** suspect **Brittany Pollard** was in complainant _____ hotel room when she sent a text message to her boyfriend, suspect **Brandon Jordan**. The text message read "I'm in RM _____ with a Mexican.. Come knock and rob his ass..hurry!!" Video surveillance from the Dallas Inn located at **3333 Marvin D. Love Freeway** in Dallas, Dallas County, Texas shows suspect **Brandon Jordan** knocking on room _____ and an unknown person opens the door. While inside the room, suspect **Brandon Jordan** shot complainant _____. The video surveillance shows the complainant run to the manager's office and it also shows suspects **Brittany Pollard** and **Brandon Jordan** run their room, room **#412**. The suspects then leave the location as the police are arriving. The complainant later died as a result of his injuries.

Suspect **Brittany Pollard** returned to the hotel, and was arrested by Officers at the scene who recognized her from the surveillance video. A search warrant was obtained for room **#412** and a **.380** handgun was recovered inside a drawer. The ammo inside the gun was consistent with the type of fired cartridges located inside room _____. Suspect **Brittany Pollard** was read her **Miranda** rights at headquarters and she provided a voluntary statement admitting to her involvement in this offense. She initially admitted she was trying to set up the complainant to get robbed stating they had done this before. However, she eventually began to recant her statements stating that she was merely prostituting while suspect **Brandon Jordan** was acting on his own. However, at no time did she change her story that **Brandon Jordan** was the one who shot and killed the complainant. A search warrant was granted to analyze the contents of her phone and the aforementioned text message to suspect **Brandon Jordan** was discovered proving suspect **Brittany Pollard** was in fact setting up complainant _____ to get robbed. Hotel records show that suspect **Brandon Jordan** had been renting the room where the presumed murder weapon was found. Suspect **Brittany Pollard** claims that she is the owner of the room and that suspect **Brandon Jordan** was renting it for her although they both stay there.
