which depicted males and females engaged in deviate sexual intercourse (sodomy by oral copulation) and sexual intercourse on it's cover. Detective took the tape to the clerk, later identified as Ray Robert Warren. The following conversation took place:

Suspect: "This is a new one, we just got it in today."

Suspect Ray rang up the sale of the video tape for a total of \$64.90 and placed it into a sack. The video tape was taken to the Vice Division and viewed in its entirety. Detective of the Dallas Police Department Vice Division who has received guidelines and general instructions in obscenity laws took the movie to the Vice Division and viewed it in its entirety. The movie is described as follows:

Scene One opens in a jail cell setting. White male, blonde hair and naked; #1 white female, dark hair and naked; #2 white female, blonde hair. White male and #1 female are having sexual intercourse when #2 female enters, #2 female then undresses and both females perform deviate sexual intercourse (sodomy by oral copulation) on the male. Male and #2 female then engage in sexual intercourse. Male ejaculates on #2 female.

Scene Two opens in a living room setting, #1 white male, dark hair and mustache; #2 white male, dark hair; white female, blonde hair. Scene opens with the female performing deviate sexual intercourse (sodomy by oral copulation) on #2 white male. Number two white male then performs deviate sexual intercourse (sodomy by oral copulation) on the female. Number two male and female engage in sexual intercourse. Female performs deviate sexual intercourse (sodomy by oral copulation) on both males. Both males ejaculate in female's mouth and breast.

Scene Three opens in a living room setting on a couch. White male with dark hair; #1 black female, naked; #2 white female, dark hair, naked. Scene opens with both females performing deviate sexual intercourse (sodomy by oral copulation) on the male. Male then has sexual intercourse with #2 female then #1 female, male ejaculates on #2 female's vagina.

Scene Four opens in a living room setting. Number 1 white male, black pants, dark hair and a hat; #2 white male, naked, dark hair; black female, naked. Scene opens with black female performing deviate sexual intercourse (sodomy by oral copulation) on #1 male, while #2 male is having sexual intercourse with the black female. Number 1 male then has sexual intercourse with the black female, while she performs deviate sexual intercourse (sodomy by oral copulation) on #2 male. Both males then ejaculate on the female's breasts.

Scene Five opens in living room setting with a couch. Black female, with black lingerie; white female, dark hair, naked; white male, brown hair, naked. Male and white female are having sexual intercourse on the floor, then the male and black female have sexual intercourse on the couch, male ejaculates on white female's buttocks and back.

Scene Six opens in living room setting. Number 1 white female wearing black lingerie, blonde hair; #1 white male, black hair and naked; #2 white male, dark hair, wearing black clothes; #3 white male, blonde hair, wearing black pants; #2 white female, brown hair and naked; black female, naked; #4 white male, dark hair, wearing black pants. Males number 1 and 2 perform deviate sexual intercourse (sodomy by oral copulation) on #1 female. Number 1 male and #1 female then engage in sexual intercourse. Black female then performs deviate sexual intercourse (sodomy by oral copulation) on #2 white male. Number 2 white female performs deviate sexual intercourse (sodomy by oral copulation) on #3 white male. Number 1 white male ejaculates in #1 white female's mouth and face. Number 4 white male and #1 white female engage in sexual intercourse. Number 4 white male ejaculates on #1 female's vacion.

Scene Seven opens in a kitchen setting. Black male, paked; #1 white female, dark hair, naked; #2 white female, brown hair, wearing a red tank top. Black male performs deviate sexual intercourse (sodomy by oral copulation) on #1 female. Black male ejaculates on #1 female's stomach.

Scene Eight opens in a bedroom setting. Number 1 white male, dark hair, naked; \$2 white male, dark hair, naked; white female, brown hair, naked; black female, black top and skirt. White female and black female perform deviate sexual intercourse (sodomy by oral copulation) on \$2 male. Number 2 male then performs deviate sexual intercourse (sodomy by oral copulation) on the white female, then the black female performs deviate sexual intercourse (sodomy by oral copulation) on white female. Number 2 white male engages in sexual intercourse with the white female, then the black female. Number 2 white male then ejaculates on the white female's face and the black female's vagina.

Scene Nine opens in a den setting. White male, brown hair, wearing a brown shirt; #1 white female, brown hair, wearing a light blue robe; #2 white female, blonde hair, wearing a green robe. Number two female performs deviate sexual intercourse (sodomy by oral copulation) on #1 female, white male has sexual intercourse with #2 white female, then #1 white female. Number one white female performs deviate sexual intercourse (sodomy by oral copulation) on #2 white female, while the white male and #1 white female engage in sexual intercourse. Male ejaculates on #1 white female's buttocks and #2 female's face.

Scene Ten opens in a hospital setting. White male, dark hair, wearing green shorts; white female, dark hair, wearing white top and bra. Female performs deviate sexual intercourse (sodomy by oral copulation) on the male. They then engage in sexual intercourse. Male then ejaculates on female's breasts.

Scene eleven opens in a living room setting. White male, brown hair, naked; #1 white female, brown hair, naked; #2 white female, black hair, black lingerie. White male performs deviate sexual intercourse (sodomy by oral copulation) on #1 female. #1 female then performs deviate sexual intercourse (sodomy by oral copulation) on the male. Number two white female performs deviate sexual intercourse (sodomy by oral copulation) on #1 white female white #1 female performs deviate sexual intercourse (sodomy by oral copulation) on the male. Male and #1 female engage in sexual intercourse, male ejaculates on #1 female's stomach.

Scene Twelve opens up in a bedroom setting. Black female wearing a gold jump suit; white female, dark hair, wearing blue pants. White female performs deviate sexual intercourse (sodomy by oral copulation) on black female. The black female and white female perform deviate sexual intercourse (sodomy by oral copulation) on the male. Male then engages in sexual intercourse with the white female, then the black female. Male ejaculates on white female's face.

The movie depicts nothing but a sequential representation of explicit sexual acts including sexual intercourse and deviate sexual intercourse (sodomy by oral copulation) between beings of different sexes. The film shows nothing but acts of sexual conduct and has no plot or development of characters except as it relates to connecting one sex scene to another sex scene. Attached as Exhibit "A" are copies of the front and back covers of the video tape box. The video tape was placed in the property division on Tag #679622. At the time of the purchase, Suspect Ray had care, custody and control of the business.
