BEFORE ME, the undersigned authority, on this day personally appeared the undersigned affiant who, after being duly sworn by me, on oath stated: My name is Eric Barnes and I am a peace officer of the City of Dallas, Dallas County, Texas. I, the affiant, have good reason and do believe that on or about the 8TH day of JULY, 20 15, one (name of suspect) MORNES, LEONARD did then and there in the City of Dallas, Dallas County, Texas commit the offense of CAPITAL MURDER, a violation of Section 19.03 of the TPC, a F1.

Affiant's belief is based upon the following facts and information which Affiant received from:

☐ _____, a fellow peace officer of the City of Dallas, Dallas County, Texas, who personally participated in the investigation of this alleged offense, providing this information to Affiant, and whose information Affiant believes to be credible.

On Wednesday July 9, 2015, at approximately 7:00 pm, Dallas Police were dispatched to 3815 W Ledbetter Drive, Dallas, Dallas County, Texas. When patrol officers arrived they were contacted by suspect Leonard Mornes (B/M 12/27/54) who was standing in the front yard of the residence. The suspect told responding officers that he shot two women who were attempting to break into his home. The responding officers entered the residence to conduct a health and welfare check and look for the injured women. When officers entered the home they found complainants and unidentified black female and Bridgitte Manning (B/F 08/23/70) deceased from what appeared to be multiple gunshot wounds. The suspect was in possession of two firearms that were believed to have been used to commit the offense.

The suspect was transported to Dallas Police Headquarters where he was mirandized and interrogated by Detective Eric Barnes #8854. The suspect told Detective Barnes that he and the complainants were hanging out at his residence smoking an undetermined amount of crack cocaine. The suspect said that he believed the complainants had already left his residence when he heard talking coming from a rear bedroom. The suspect retrieved a handgun and entered the bedroom firing shots at the complainants. The suspect chased the complainant's through the residence and continued to fire shots until the complainants became incapacitated. The suspect later revealed that he believed the complainants were secret agents sent to spy on him and that they replaced the real bullets in his guns with blanks. Both female complainants suffered gunshot wounds and died at the scene as a result of their injuries. The suspect was transported and booked in to Lew Sterrett Justice facility.
